CONTEST RULES

Contest begins February 17th 2020 at 8:00AM, Eastern Time, and ends on March 8th, 2020 at 11:59 PM, Eastern Time (the "Contest Period").

1. HOW TO ENTER

No purchase required. To enter the contest, simply visit monbossestrie.ca and complete the [entry form](#).

All entries must be received by March 8th, 2020 by 11:59 PM, Eastern Time, at the latest.

Limit of one entry per person.

2. ELIGIBILITY

Participants must be residents of the Eastern Townships region, must have student status and be employed at same time and be 13 years or older.

Employers named by the participants must comply with the following conditions:

- Offer a work schedule not exceeding 20 hours per week during the course of the studies.
- Must adapt work schedule to exams, studies or school work periods.
- Inquire about their student-employees' academic success.
- Encourage their student-employees with respect to their school projects.
- Allow their student-employees to work with some autonomy.
- Any other aspects important to the participants.

* In order to simplify the text, for the rest of the document, the Corporation de développement de l'entrepreneuriat collectif de Sherbrooke (CDEC) will be included when the Carrefours jeunesse-emploi de l'Estrie is discussed.

Projet PRÉE and Carrefours Jeunesse-emploi de l'Estrie employees are not eligible to enter the contest.

By participating in this contest, entrants agree to comply with the rules.

The Prize Sponsors and their Partners reserve the right to disqualify any entry deemed inappropriate or not meeting the eligibility and participation conditions.

3. HOW PRIZES ARE AWARDED

Members of the Projet PRÉE and the various Carrefours jeunesse-emploi de l'Estrie, as well as any other person considered relevant, will compose the jury responsible for evaluating the employers proposed in the registration forms. Of these, seven employers will be selected, one for each Carrefour jeunesse-emploi located in the Eastern Townships.

Subsequently, the jury will anonymously assess the forms submitted by the entrants who had chosen the selected employers. Among this final group of entrants, seven winners will be retained based on the quality of their submission (one per Carrefour jeunesse-emploi).

Winners will be contacted the week of April 5th, 2020.

All of the winning participants, having fulfilled all of the above conditions, will receive a notice by email or telephone within twenty-four (24) working hours of the nomination to inform that they have won and to validate their contact information. The Prize Sponsors and their Partners cannot be held responsible for any failed attempt to contact a selected participant.

If any given winner cannot be reached by email or telephone within forty-eight (48) working hours of the appointment, the participant will be deemed to have refused the prize and will be declared ineligible. Another participant will then be drawn from among the other eligible entries until a new winner is declared.

4. PRIZES

Seven (7) prizes consisting of a 100\$ gift card will be awarded to each winning entrant, one (1) gift card for each Carrefour jeunesse-emploi. The entrant will be allowed to select what kind of gift card they wish to receive (e.g. book store, telephone provider, restaurant, gaz, etc.). The Prize Sponsors reserve the right to approve or not the choice of card.

Gift cards are subject to availability. The Prize must be accepted "as is", without substitution. It cannot be sold or redeemed for cash.
